End User License Agreement

This is a license agreement and not an agreement for sale. This license agreement (Agreement) is between the end user (Licensee or you) and Global Mapping International (GMI), and gives Licensee certain limited rights to use the Global Ministry Mapping System data; geographic information system software; software updates and extensions; sample data; online and/or hard-copy documentation and user guides, including updates thereto; and software keycode or hardware key, as applicable (Global Ministry Mapping System or GMMS). All rights not specifically granted in this Agreement are reserved to GMI.

1. **Reservation of Ownership and Grant of License:** GMI and its third party licensor(s) retain exclusive rights, title, and ownership of the copy of the Software, Data, and Related Materials licensed under this Agreement and, hereby, grant to Licensee a personal, nonexclusive license to use the Software, Data, and Related Materials based on the terms and conditions of this Agreement. From the date of receipt, Licensee agrees to use reasonable effort to protect the Software, Data, and Related Materials from unauthorized use, reproduction, distribution, or publication.

2. **Copyright:** The installation software, documentation and data files comprising the GMMS are copyrighted by Global Mapping International (GMI) and its licensors, including, but not limited to, Environmental Systems Research Institute (Esri), under U.S. and International Copyright.
3. **Eligible Licensees:** This GMMS may be licensed only by recognized nonprofit organizations in the United States or by equivalent organizations overseas. Licensed organizations must have demonstrated to GMI through an application process that they are actively involved in the promotion or propagation of the Christian faith, and that the GMMS will be used solely to further those ends. If you have purchased this product and are not a qualified Licensee, or are unwilling or unable to comply with the terms of this license, you must return this product immediately to GMI for a full refund.
4. **Single-Computer License:** The geographic data, tabular data, map projects, GIS software, software extensions, and electronic documentation included with the GMMS may be installed and used on only one computer computer, with the following exceptions:
 - 4.1. GMI has issued you an explicit, written, license addendum permitting use of the GMMS on multiple computers.
 - 4.2. To the extent that that the Esri end-user license for a version of ArcGIS for Desktop Basic provided with the GMMS contains language permitting a second copy of the software to be installed for the licensee's exclusive use on a portable computer so long as only one copy of the software is used at any one time, the GMMS Software, Data, and Related Materials may be used on a portable computer on the same terms.
 - 4.3. The GMMS data (geographic data, tabular data, and map projects) may be installed on a network server, but solely for use by computers for which GMMS licenses have been obtained.
 - 4.4. Interactive "packages" containing GMMS data produced using the ArcGIS Publisher extension for reading with ArcReader, and packages produced using ArcGIS Desktop for publication on the World Wide Web using ArcGIS Server or ArcGIS Online may be run on other computers, provided that the settings used in creating the package and, where applicable, the ArcGIS Server settings do not allow end-users of the published material to use, extract, or download vector GIS or tabular attribute data, that the material otherwise conforms to the terms of this license, and that a test environment demonstrating compliance with these terms is made available to GMI for approval not less than three weeks prior to publication.
5. **Software and Data Not Separable:** software provided with the GMMS package, whether or not provided on separate media, may not be separated from the GMMS data for use on a different computer.
6. **Other Licenses:** GIS software, extensions, documentation readers, data supplements, or other items pertaining to the GMMS may include end-user licenses as part of their installation software and/or documentation. The terms of such licenses are binding on the Licensee. Where the terms of any additional end-user license conflict with those of this agreement, the more restrictive terms shall apply.
7. **Designated End-User:** The Licensee organization must identify to GMI an individual end-user who will have oversight of the system and be responsible for organizational compliance with this license.
8. **License Transfers:** This license may be transferred only to another qualified Licensee with the prior, written permission of GMI. The current Licensee must transfer all versions of distribution media received, including all GIS software, GMMS data, and hardware keys received as part of the GMMS, whether on GMI, Esri, or other media, and must remove all electronic forms of the GMMS data and GIS software from current Licensee's computers.
9. **Upgrade License:** If this product was purchased as an upgrade, this license supersedes the license of any previous versions of the Global Ministry Mapping System, Global Mission Base Map or Language Mapping System. Previous versions of the data and its distribution media may be retained

by the Licensee, returned to GMI, or destroyed, but may not be transferred unless all versions received are transferred as described above.

10. **Derivative Data:** Licensee may produce and retain on the same physical computer medium as the GMMS data derivatives of the GMMS in electronic form, including, but not limited to, conversions of the data into other data formats, extracts or aggregations of the data, graphical or cartographic representations of the data, or revisions to the data. Such derivatives are for the exclusive use of the Licensee.
11. **Backups:** Licensee may make and retain in the Licensee's possession such copies of the GMMS and any derivative works as may be required for archival backup purposes.
12. **Redistribution of Data to Other GMMS Licensees:** Licensee may redistribute geographic, attribute, or project data partially derived from the GMMS to other GMMS Licensees, provided:
 - 12.1. The Licensee redistributing the data has either posted the derivative data to the appropriate area of a GMI-maintained web site having file exchange areas for Licensees of particular GMMS products, or has verified with GMI that the proposed recipient has a valid license for the same or greater version of the GMMS product from which the redistributed material was derived.
 - 12.2. The recipients are notified of the nature of the modifications to the GMMS data.
 - 12.3. Recipients are notified that the portions of the data derived from the GMMS remain subject to the terms of the GMMS license.

A form suitable for providing the required notices is available from GMI on request.

13. **Publication and Distribution of Maps:** Licensee may make, reproduce, and distribute by any means any cartographic representation of the GMMS data, alone or in combination with other data, in printed or graphical file form, provided:
 - 13.1. The graphical file formats used do not contain geographically referenced data usable in a geographic information system. **Note in particular that Google Earth KML/KMZ files and similar overlay files for Internet-based mapping are geographically referenced data and may not be exported without specific, written permission from GMI.**
 - 13.2. Source attribution(s) as follows are included on each map:
 - 13.2.1. For any sample map provided with the GMMS and not substantially modified, retain attributions as they appear on the map.
 - 13.2.2. For any new or substantially modified map containing substantial GMMS data, include the attribution "Geography from GMMS 2013, Global Mapping International". If space permits, expanding "GMMS" to "Global Ministry Mapping System" and/or including the web address "www.gmi.org/gmms" is encouraged.
 - 13.2.3. If language points or polygons are included in the map, include the additional attribution "Language locations from World Language Mapping System version 16 (2011) www.gmi.org/wlms".
 - 13.2.4. If data from the UNICEF State of the World's Children is included in the map, include the additional attribution "Data from UNICEF *The State of the World's Children 2010* <http://www.unicef.org/sowc>" Maps published on the web or electronically should include a working hyperlink.
 - 13.2.5. Other data sources should be cited where reasonably feasible.

Exception: If maps are an integral part of a larger publication, and if the publication size or resolution of the maps does not reasonably allow inclusion of the above attributions in the map itself, attribution may be placed in text outside the map image, provided a clear reference to the location of the attribution text is provided near the image. For maps appearing as screen-resolution

images in HTML documents on the Web or other hypertext electronic publications, the attribution may appear in a separate document accessed by a hyperlink from the document(s) in which the map(s) appear(s).

14. **Other Documents Produced with GMMS Data:** Database reports or other non-cartographic representations of data included in the GMMS may be produced and used for the internal planning purposes of the Licensee organization, provided:
 - 14.1. Documents are distributed only in print or print-equivalent electronic formats such as PDF.
 - 14.2. Documents are clearly marked “Internal Use Only – Not for Publication or Distribution” and clearly identify both the GMMS and the underlying source of the data.
15. **Other Reproduction Prohibited:** Reproduction or redistribution of any portion of the GMMS or any derivative work in any printed or electronic form except as described above is prohibited without prior written permission from Global Mapping International, PO Box 63719, Colorado Springs CO 80962-3917 USA or permissions@gmi.org.

Limited Warranty and Limitation of Liability

For a period of 30 days from the date the GMMS is acquired by you, GMI warrants that the media upon which the GMMS resides will be free of defects that prevent you from loading the GMMS on your computer. GMI's sole obligation under this warranty is to replace any defective media, provided you have given GMI notice of the defect within such 30-day period. The GMMS is licensed to you on an "AS IS" basis without any warranty of any nature. GMI disclaims all other warranties, express or implied, including the warranties of merchantability and fitness for a particular purpose. GMI shall not be liable for any damage or loss of any kind arising out of or arising from your possession and use of the GMMS (including data loss or corruption), regardless of whether such liability is based in tort, contract, or otherwise. If the forgoing limitation is held to be unenforceable, GMI's maximum liability to you shall not exceed the amount of the license fees paid by you for the GMMS. The remedies available to you against GMI under this agreement are exclusive. Some states do not allow the limitation or exclusion of implied Warranties or liability for incidental and consequential damages, so the above limitations or other exclusions may not apply to you.
